SA Government – Digital Donation Program

The Digital Donation Program was created to assist South Australian community based, not-for-profit organisations to access devices from surplus government stocks. By re-using surplus government devices across the State and making them available to non-for-profit organisations in the community, we are able to implement a program that benefits both the community and our planet.

Organisations must be eligible for the program and meet the specific requirements. The devices are free and the maximum amount for each eligible organisation is three.

Successful applicants can collect their devices at a pre-arranged time from the Computer Recycling Warehouse in Burton.

The Council of Registered Ethical Security Testers Australia and New Zealand (CREST ANZ) is approved to conduct cyber security health checks with small business. The aim of the program is to help small business understand their cyber security vulnerabilities and then make considered investments to protect their business. The program will run for the remainder of 2019/20.

PIRSA On-Farm Emergency Water Infrastructure Rebate Scheme

The Australian and SA Governments are offering a rebate to drought affected farmers who invest in urgently-needed on-farm water infrastructure for livestock.

Eligible farmers can access a 50% rebate – up to \$50,000 – on new purchases and installation costs for on-farm water infrastructure to help them provide water to livestock in the current drought and be better prepared for future dry conditions. Farmers will be eligible to apply through PIRSA for the rebates, which will also cover eligible work undertaken since 1 July 2018

NRM Back to Basics Grant

The Northern and Yorke NRM Board invites land managers and community groups situated within the Southern Finders Upper North (SFUP), Lower Mid North (LMN) and Yorke Peninsula (YP) districts to apply for the Northern and Yorke Natural Resources Management Board's Back to Basics Grants Program.

The Northern and Yorke NRM Board's Back to Basics Grants program has been established to provide funding to land managers and community groups to undertake projects that deliver positive environmental outcomes in Pest Management and Sustainable Agriculture practices across the Northern and Yorke Region. Grants of up to \$5000 (plus in-kind contributions and landholder/ community group commitment) are available for projects such as coordinated pest management and weed control.

Caravan Parks Defib Subsidy

In 2019, the Federal Government in partnership with Caravan Industry Association of Australia, launched a Caravan Park Defibrillator Subsidy Program for Caravan Parks to encourage operators to install these devices to help save the lives of those people experiencing a sudden cardiac arrest. The funding of \$1 million from the government will match dollar to dollar up to \$1000 per unit (excluding GST) purchased by an operator.



In regional Australia, the caravan park is often central to the community and one of the few businesses that is accessible 24h a day 7 days a week in the event of required access to a defibrillator. Although there has been an increased supply of defibs into sporting clubs, these venues are only accessible when sports are being played. As such, Caravan Parks can play an important role in supporting a local community's health service.

Arts, Culture & Music Grants

The Department of the Premier and Cabinet is responsible for the administration of arts and culture grant programs.

Carefully targeted programs support artists and organisations through flexible funding arrangements that include triennial, annual and project-specific agreements.

Round 3 will open in early 2020.

**FRRR Strengthening Rural Communities**

The Strengthening Rural Communities (SRC) program aims to give the thousands of small rural, regional and remote communities across Australia an opportunity to apply for funding that can support broad community needs.

The program criteria are deliberately flexible, and with applications being accepted all year round, communities have increased access to funds that can be used where and when a community knows it's needed.

The Strengthening Rural Communities program has two funding tiers:

1. Small & Vital grants

Small & Vital grants are all about meeting an immediate small scale need within a community, or for giving a boost to a larger initiative.

- The Small & Vital grants provide funds of up to \$10,000.
- Applications are accepted year round via our online application system and awarded quarterly.

2. Larger Leverage grants

Through the Larger Leverage grants, small rural, regional and remote communities now have an opportunity to access funding to support more aspirational objectives, think bigger and leverage the ideas, creativity and resources of communities for bigger impacts and stronger, more connected communities.

The Larger Leverage tier is focussed on supporting two types of projects:

Remote communities | Additional Financial Support required

Expressions of interest (EOI) are required to apply for this tier, deadlines for which are listed below.

- The larger leverage grants provide funds between \$10,001 to \$25,000.
- Community groups can apply for the larger leverage grants twice a year

Coast Participation Grants

The Coast Protection Board's Coastal Participation Grants support volunteer groups to partner with local government to undertake small-scale coastal management initiatives. Grants of up to \$10,000 are available. The grant funding will be delivered by the Coast Protection Board with the support of the Department for Environment and Water (DEW). In accordance with the Coast Protection Act 1972, the Board can provide grants of up to 80 per cent of the total cost of approved coastal projects. Applicants must contribute a minimum of 20 per cent of the total project costs, which can include cash or in-kind support.

Bite-Size Grants

The Northern and Yorke NRM Board's Grants program provides funding to community groups and not-for-profit organisations to enable them to undertake projects that deliver positive environmental outcomes across the Northern and Yorke NRM Region.

A portion of the Community Grants budget has been allocated to the Bite-Size Grants program, to provide support for small, short-term projects ranging from \$200 - \$500.

This program is funded through the Northern and Yorke Natural Resources Management Board and particular NRM priorities must be met. Project funds must be acquitted, and a completion report submitted within 3 months of receiving the grant money.



These grants are designed to increase awareness and positive action for groups in NRM and sustainability in project areas such as garden development, weed control, revegetation etc. Potential projects may fund training events, purchase of resources, contracting services or development of educational materials.

Youngcare's Home Support Grant can provide funding where there are critical gaps in an NDIS participant's plan, but there is still clear evidence of need. The grant also seeks to bridge the gap in essential services and support for families in need, during the transitional period while the NDIS is fully established.

The Retailer Energy Efficiency Scheme (REES)

A South Australian Government energy efficiency scheme that provides incentives for South Australian households and businesses to save energy. It does this through establishing energy efficiency and audit targets to be met by electricity and gas retailers.

South Australian households and businesses may be able to access discounted or free energy efficiency activities from energy retailers participating in the REES. Low-income households may also be able to receive an energy audit.

The Minister has set the approved REES energy efficiency activities; however, each energy retailer participating in the scheme decides on what mix of those energy efficiency activities it will undertake to meet its targets.

To find out what activities energy retailers are currently offering, you can contact any of the obliged energy retailers in South Australia, not just the retailer currently supplying you. Energy retailers may contract out their energy audits and energy efficiency activities to third-party contractors, and you may also contact these third-party contractors directly.

2020 GOVERNOR'S CIVICS AWARDS FOR SCHOOLS

The Governor's Civics Awards for Schools is a cross-sector initiative open to all South Australian schools, including government, Catholic and independent. The awards aim to develop student awareness and skills as active and informed citizens in a multicultural and democratic society.



They have been designed to align to the Australian Curriculum: History and Civics and Citizenship.

In 2020 the awards are available for years 5 to 12 and include individual, group and school categories. In the individual category students will respond to a history and/or civics question. In the group category schools will submit the work of a school group in the area of civic involvement. The school's category invites schools to nominate their civics and citizenship education program as an example of outstanding practice.

A maximum of 4 individual student entries and 2 group nominations per school can be forwarded for judging by the Governor's Civics Awards for Schools judging panel.

The winners of the 2020 awards will be announced on Proclamation Day 2020 and awardees will be invited to a reception at Government House to receive their awards early in 2021.
