



The Logosynthesis® Online Master Practitioner Program

Introduction

Certification as a Practitioner in Logosynthesis® is an important step in your development as a professional working with the model. This document describes the concept, the design, and the structure of an international online training program to become a *Master Practitioner in Logosynthesis®*.

The international expansion of the Logosynthesis community has created the need for such a program: Many members don't have the resources for international travel. The corona crisis has created additional difficulties in attending onsite seminars with Logosynthesis Trainers.

The training and certification of professionals in the field have been important objectives for the Logosynthesis International Association since it was founded in 2015. The LIA has assessed criteria for the following types of training and certification:

1. Practitioner in Logosynthesis®
2. Instructor in Logosynthesis®
3. Master Practitioner in Logosynthesis®
4. Trainer in Logosynthesis®

The LIA Training Committee designs the content and the criteria for training and certification, and the LIA Certification Committee is responsible for the certification procedures. The LIA Board decides on these rules and regulations.

The *Practitioner in Logosynthesis®* curriculum is focused on learning the basics of philosophy, the theory, the methods, and the applications of Logosynthesis, mainly on a theoretical and technical level. The program consists of a Logosynthesis Basic workshop, seminars on fields of application (The Path of Trust, The Path of Courage, The Path of the Will), participation in an experiential seminar (Logosynthesis Live), supervision sessions, and practice group sessions.

Certification as an *Instructor in Logosynthesis®* allows Practitioners to offer introductory seminars on Logosynthesis and its applications to laypersons. However, Instructors are not entitled to train other professionals: This will always be the domain of certified Trainers.

The next level of training after certification as a Practitioner is the curriculum to become a *Master Practitioner in Logosynthesis®*, which is the subject of these documents. You find the description of the current LIA training and certification process in the [LIA training handbook](#).

The Philosophy of the Online Master Practitioner Curriculum

Logosynthesis is more than just one set of concepts and techniques. It's an encompassing system for healing as well as for personal and spiritual development. The emphasis in the Practitioner curriculum is mainly on the resolution of trauma and dissociation, allowing the trainee to reconnect to Essence and to free the energy of the Self.

The fundamentals of the Logosynthesis model are taught at the Practitioner level. The participants learn to apply the model in their practice, but the curriculum also creates the conditions for discovering an even deeper meaning in and use for the model.

The Online Master Practitioner curriculum will create a space for the unfolding of the candidates' potential – beyond strict protocols, in tune with their Free Self. The theoretical model, as taught in Logosynthesis Basic, is vastly expanded, and a wealth of additional methods is presented.

Logosynthesis is not finished. It's in a process of continuous development. For that reason, the Online Master Practitioner curriculum will also be a laboratory for new developments in Logosynthesis. Participants will be among the first to learn about new theories and applications.

Learning Logosynthesis at the Master level is deeply individual, and at the same time it's embedded in an intensive group experience. The safe environment of the online training group and its practice groups will allow you to explore and resolve blocks and to unlock your potential for the fulfillment of your deeply personal mission.

This program is designed to use all the advantages of online learning as they have become available in the past few years. At the same time, it contains crucial process elements that until now have not been used in online Logosynthesis learning. To allow this structure to unfold its maximal effect, we will work with a closed training group for periods of one year each. After each year, people can decide to continue the program for the next module, and new members are admitted.

Structure of the Program

The program consists of two one-year modules and will be offered in English. The training group of each module will remain constant. Candidates can participate in one or in both modules. They can also decide to participate in only one module and attend the rest of the MPL curriculum in other forms.

Each module contains the following elements:

1. Online workshop sequences on theory and methods – Master Classes. Each sequence will depart from an existing Master Class theme, with added space for new developments: The Logosynthesis system is continuously expanding, and a predefined content would not match the process character of this training.
2. Handouts and video recordings of these workshops will be made available to the group.
3. Online lab sessions, with opportunities for exploration of the process of individual members, of the practice groups, and of the dynamics of the training group as a whole, with a particular focus on transference and countertransference in the learning environment.
4. Process notes, to be made after each online session. Guidelines on creating these process notes will be provided at the beginning of the curriculum.
5. International online or onsite practice groups. These groups can also work in other languages. They are planned independently from the large group online sessions, with a high degree of shared responsibility among the participants.
6. A dedicated social media group, probably on Facebook, to discuss the philosophy, attitude, theory, and methods of Logosynthesis at this advanced level, moderated by the program director.
7. Reading and discussion of Logosynthesis literature.
8. Individual mentoring, according to the LIA training regulations.
9. A written report (4-6 pages) on the personal process of the candidate at the end of the module.

Between the two modules, candidates will attend the Logosynthesis Summer conference as a live group experience. If live attendance is not possible, the candidate can discuss alternatives with the program director.

Train-the-Trainer

The Logosynthesis Online Master Practitioner Program also contains an exceptional opportunity for experienced Trainers in Logosynthesis® who want to become licensed to offer elements of the Master Practitioner curriculum. Candidates for this part of the program:

- have acquired all licenses for the Practitioner curriculum
- are actively offering these seminars on the market online or onsite
- make a contract for participation during both years of the program
- attend the yearly Lanzarote Master Class in both years of the curriculum

- participate in the Logosynthesis Summer Conference, as a trainee or as a staff member
- participate in a dedicated practice group to explore the issues of training on the Master Practitioner level
- receive regular supervision in this practice group from Dr. Willem Lammers or other Master Practitioner Trainers
- participate in a dedicated Facebook group which focuses on training and development at the Master Practitioner level
- write a report (8-10 pages) to the LIA Training Committee on their process and on the process of the training system at the end of the module.
- are willing to serve as mentors for the Master Practitioner candidates in the program.

Target Group

Practitioners, Instructors, Master Practitioners, and Trainers in Logosynthesis can apply for registration in this program. If you're planning to fulfill the obligations of the Practitioner certification soon, you can also apply for participation. If you are already registered as a Master Practitioner, this is an excellent opportunity to heighten your competence in the field of Logosynthesis. The minimum size of each group is 12 members.

Trainer and Staff

Dr. Willem Lammers, author, founder, and developer of Logosynthesis®, will be the director of the program 2021-2023. Other Master Trainers will assist him.

Dates, Times and Themes

The online part of the program consists of two-hour online sessions on Tuesdays, at 16:00-18:00 CET. Depending on the process of the group, the content of sessions can be changed or additional sessions can be scheduled.

Module 1, August 2021 – May 2022

- 2021: The Path of Presence
August 31; September 14, 28; October 12, 26; November 9, 23; December 7
- 2022: The Path of Creation
January 18; February 1, 15; March 1, 15, April 26; May 10, 24

Module 2, August 2022 – May 2023

- 2022: The Path of the Self
August 30; September 13, 27; October 11, 25; November 8, 22; December 6
- 2023: The Path into the World
January 17, 31; February 14, 28; March 14, 28; April 25; May 16.

Fees and Payment

The participation fees are comparable with the usual prices for training at a Master Practitioner level. Each one-year module costs CHF 1'100.-, of which 50% is paid after confirmation of your registration and the other 50% on February 1, through PayPal or IBAN.

Participants in the Train-the-Trainer part of the program pay CHF 200.- per module for the additional supervision sessions in their practice groups.

Fees for individual mentoring are not included in this fee and are negotiated with the candidate's mentor. Participation in the Summer Conference or the Lanzarote Master Class is also not included.

Registration and Admission

Candidates apply for the program with a short description of their motivation, a c.v. and an overview of the Logosynthesis training they attended. An application does not mean that a person will automatically be admitted. The program director will decide on admissions.
