U.S. DEPARTMENT OF THE TREASURY HOMEOWNER ASSISTANCE FUND

Data and Methodology for Allocations to Indian Tribes and Tribally Designated Housing Entities September 20, 2021

Section 3206 of the American Rescue Plan Act of 2021 (the "Act") established the Homeowner Assistance Fund ("HAF") to mitigate financial hardships associated with the coronavirus pandemic by delivering mortgage payment and other financial assistance to homeowners. The statute sets aside 5% of the appropriation for payments to (i) the Department of Hawaiian Homelands (DHHL) and (ii) Indian Tribes or their Tribally Designated Housing Entities ("Indian Tribes"), with Treasury directed to disburse 0.3% of such amount to DHHL.

The statute requires Treasury to allocate the remaining \$496,555,850 in accordance with the formula described in Section 501(b)(2)(A)(ii) of subtitle A of title V of division N of the Consolidated Appropriations Act, 2021. Section 501 established the Emergency Rental Assistance (ERA) Program with Section 501(b)(2)(A)(ii) providing the methodology for determining each Indian Tribe's ERA allocation (the "ERA Methodology").

The ERA Methodology is based on the amounts Indian Tribes received through the F.Y. 2020 Indian Housing Block Grant (IHBG) Program and would generally afford each Indian Tribe the same proportion of the \$496,555,850 as it was eligible to receive of the total IHGB funding for F.Y. 2020. However, the ERA Methodology also required Treasury to afford Indian Tribes who chose not to participate in the F.Y. 2020 IHBG Program thirty (30) days to determine whether to participate in the ERA Program and, by extension, HAF.

Three otherwise eligible Indian Tribes elected not to receive funding through the IHBG Program in F.Y. 2020: Chicken Ranch Rancheria of Me-Wuk Indians ("Chicken Ranch"); Mohegan Tribe of Indians of Connecticut ("Mohegan"); and Prairie Island Indian Community ("Prairie Island"). After consultation with Treasury, all three elected to participate in the HAF Program.

To include Chicken Ranch, Mohegan, and Prairies Island in the HAF allocation, the ERA Methodology requires Treasury to apply the ratios from the IHBG allocations against the \$496,555,850 in available HAF funds; add Chicken Ranch, Mohegan, and Prairie Island into the allocation formula at an amount determined by the Secretary; and make pro-rata reductions to ensure the total allocations do not exceed the \$496,555,850.1

To determine the amounts to add for Chicken Ranch, Mohegan, and Prairies Island, Treasury asked HUD to recompute the F.Y. IHBG allocations as though all three had participated in the program. Treasury then assigned an HAF allocation for each set to their equivalent shares of the total IHBG funding that each would have received in F.Y. 2020. This approach treats Chicken Ranch, Mohegan, and Prairie Island equitably because it uses the same allocation framework as applied to the other Indian Tribes. Further, it uses data available from HUD to make the computation and thereby does not place other participating Indian Tribes at a disadvantage.

Treasury then made pro-rata reductions as provided by the ERA Methodology to ensure the total HAF funding for Indian Tribes did not exceed the available \$496,555,850.
